



Privacy Statement

Sonolize respects the privacy of all users of its website and ensures that the personal information that the user possibly provides to Sonolize, through the use of our services and in the electronic communications sent through or in connection with our services, is always being treated confidential and in accordance with the General Data Protection Regulation (GDPR / AVG).

This policy describes the types of information that we may collect from you when you access our website, www.sonolize.com, or interact with us and our practices for collecting, using, maintaining, protecting and disclosing that information.

This policy is effective from the 1st September 2019. By using or subscribing at www.sonolize.com you consent to this policy.

1. What personal data do we collect and why?

In general, you can visit our website without telling us who you are and without revealing any information about yourself. If, however, you wish to buy sheet music or as a composer offer your sheet music then you enter into a contract with us for goods/services and you will need to register your full contact details.

Sonolize may process personal data about you, because you make use of the services of Sonolize and /or because you provide it yourself when filling in an order or you sign up for a newsletter.

Sonolize processes the following personal data:

- When you are a buyer: your name, address details and e-mail address.
- When you are a composer: your name, address details, e-mail address, personal website, bank account number, biography information and profile photos.

By providing the data to us you give us permission to use the data for the following purposes:

- Offer you the possibility to create an account.
- Respond to general information requests.
- Purchase of products offered through the Sonolize platform.
- Offer products at the Sonolize platform.
- Handling your payment.
- Sending our newsletter.

Sonolize does not store your personal data longer than is strictly necessary to achieve the goals for which your data is collected. The tax authorities prescribe that an administration must be kept for 7 years.

2. Payments

Sonolize uses various payment options. All payments to buy sheet music at our website are handled by an external Payment Service Provider (PSP). The PSP processes your name, address and your payment details such as your bank account or credit card number. Like all our partners, this PSP has taken appropriate technical and organizational measures to protect your personal data and all information is always treated confidentially and in accordance with the General Data Protection Regulation (GDPR / AVG)

3. Sharing information with third parties

Your personal data is stored on the servers of Trans-IP in Amsterdam. This provider is GDPR / AVG compliant.

Sonolize may exchange personal data in the context of its services. Sonolize may use third-party services for the aforementioned purposes, such as the suppliers of our website and our systems or financial administration. In the context of this, personal data is provided to these third parties. These third parties may only process your personal data for the aforementioned purposes.

Finally, your personal data may be provided to third parties if Sonolize must comply with a legal obligation. We will not provide your information for commercial or charity purposes.

With some regularity we send (through an external partner) newsletters to the e-mail address you have provided. In these newsletters you are offered the possibility to prevent future sending of newsletters by unsubscribing via the link 'Unsubscribe'.

We appreciate if our customers like to receive our newsletters but always do respect if they unsubscribe.

4. How we protect your data

Sonolize protects your data with technical and administrative security measures. In this way we minimize the risk of loss, misuse, unauthorized access and disclosure. For this we use firewalls, encryption of data and physical and administrative barriers to the data and servers. If you still think that data has been misused, please do contact us.

5. Marketing activities

In the context of our marketing activities, Sonolize keeps general data of visitors to its website. In particular, the IP address of your computer, the time of retrieval and data sent by the browser can be registered and used for statistical analysis of visitor behavior on the website. The data is made anonymous as much as possible.

6. Your rights

You always have the right to view your personal data and the right to rectify your personal data. If you want to know which personal data, we process about you, you can submit a written request for inspection. If your information is incorrect, incomplete or irrelevant, you can request us in writing to change or supplement your information.

In addition, you have the right to delete your personal data, a right to limit processing and a right to object to the processing. In addition, you are entitled to transferring or making your data transferable. You can also submit a written request for this. The withdrawal of this permission does not affect the legality of our data processing based on your permission that took place before this withdrawal.

Account holders may request Sonolize to delete the personal data associated with an account as soon as the account is deleted. In any case, we ensure that personal data is not stored by us for longer than necessary and in any case no longer than 7 years.

We will process your request within 4 weeks. Written also means an e-mail. You can send your e-mail request to jake@sonolize.com.

7. Cookies

A cookie is a small file that is sent by our website and placed by your browser on the device with which you visit our website. Cookies are used for the best possible functioning of this website. The information stored in the cookie can be sent back to our website when you visit the website again. By using our website, you accept its use.

Google Analytics

Because we want to know how our visitors use the website, so we can optimize the use of it, we use Google Analytics. Analytical cookies from Google are therefore placed through our website. The information is made anonymous as much as possible. Your IP address is explicitly not used. We can't therefore trace you personally.
